LC72 **Public Participation**

Geoff Nicholls – Rimutaka mountain bikers

Mr Nicholls, representing a group of mountain bikers, outlined their proposal to set up a downhill mountain biking park in the Martin's Block plantation forest, next to the Tunnel Gully Recreation Area. The proposal would complement the Makara cross-country course. The group intends to become an incorporated society.

Mr Nicholls discussed several issues related to establishing the proposed park, including:

- Tracks would follow natural contours, be essentially “rough” and not damage tree roots.
- Tracks would be constructed and maintained by volunteers
- There may be some conflicts between the bikers and other users
- Signage would be sponsored by Upper Hutt City Council
- Once the Club was formed, it would obtain public liability insurance before track construction began.
- The group hopes to complete both phases of the project as soon as possible.

Cr Bonner requested a copy of costings for the Hutt River Floodplain Management “Design Standard”.

Cr Thomas noted that in question (3) under HRF51 of the Advisory Committee’s report, she referred to the Ava Rail Bridge rather than the bridge at Silverstream.

Cr Macaskill left the meeting at 10.38am on other Council business that required urgent attention. The Committee agreed that this item be laid on the table until Cr Macaskill returned.

LC76 Future Direction for East Harbour Regional Park

Anne Manley, Parks Planner – Policy, Regional Parks (Strategy and Marketing), was present for this item.

Cr Macaskill returned at 11.05am.

Members agreed that access and land rationalisation remained central to the Park’s future development potential.

Cr Shaw wanted to see a region-wide strategy developed between the Wellington Regional Council, the Department of Conservation and the territorial authorities on the current and prospective ownership of public land. Cr Werry would like a workshop on future Regional Park opportunities.

Mr Gilbert noted creative options for linking the two land blocks in East Harbour Regional Park, such as in the Netherlands where the authorities buy access rights from landowners on an annual basis without alienation of the land.

Members also wanted more certainty on the future status of the Northern Block.

Cr Shields said private sponsorship options should be considered for any proposed educational centre.

Resolved

That the Landcare Committee:

- (1) Receive the report and note the contents.*
- (2) Note the recreation, environment, and heritage Signature Values of East Harbour Regional Park.*
- (3) Agree that the Lakes Block, Baring Head and the coastal margins are the key elements of the Park.*
- (4) Agree that the fundamental issues to be resolved for the future of East Harbour Regional Park are land rationalisation and access, and that these issues need to be addressed before progressing with plans for new recreation, environmental or heritage initiatives in the Park.*
- (5) Agree that serious attention be given to alternative road access to the southern end of the Park.*
- (6) Agree to officers exploring opportunities with the other Park landowners to the WRC becoming the lead agency in East Harbour Regional Park.*
- (7) Note the proposed timetable for progressing work on East Harbour Regional Park during Years 1–4 (1999/2000–2002/2003).*

- (8) Note that public consultation will be undertaken through a visitor survey (in 2000) and the review of the Management Plan (from 2001) incorporating discussion on the continued inclusion of the Northern Block in the Park, and Development Concept 2 for the*

Lakes Block.

- (9) *Note the opportunities to contribute to key Council objectives and outcomes through maintaining and/or enhancing the values at East Harbour Regional Park (e.g. Regional Policy Statement implementation, biodiversity, and the Environmental Education and Communication Strategy).*
- (10) *Note that development of East Harbour Regional Park will be addressed as part of the next Long-term Financial Strategy.*
- (11) *Note that to fund any land purchase, it may be necessary to access the Land Purchase Reserve in the future.*
- (12) *Request officers to provide advice on the mechanisms and opportunities to achieve a rationalisation of the ownership, management and development of public recreation lands in the Wellington Region.*
