# **Resource Consents (Non-Notified)**

#### 1. Purpose

To report on decisions made under delegated authority on non-notified resource consent applications.

## 2. Format

Our new database is up and running, and as a consequence, the format of our Non-Notified Consent Report has changed. From now on each resource consent we grant will be listed in a spreadsheet.

The order in which the resource consents are reported has changed too. Instead of the consents being reported by consent type, they are now reported by consent number. Hence if a project involves more than one type of resource consent, the consents will be grouped together. The new layout should make it easier for you to get a picture of all of the works which are being undertaken in each location.

## 3. Resource Consents Approved

The resource consents we have approved between 14 August 1999 and 22 September 1999 are listed on the attached spreadsheet.

## 4. Gravel Consents Issued by Reach

72 Gravel Consents have also been granted during the August/September period. These consents were applications that were on hold awaiting the outcome of the Ruamahanga Catchment Consent applied for by the Operations Department. As this consent decision has been appealed, the applications that were on hold, have now had to be processed.

As the processing of these applications have been done as a one-off exercise and data entry is not yet complete on the database, it has been decided to report numbers of consents issued and volumes per river/reach. All consents are due to expire 30 June 2001. It is hoped that the appeal on the Ruamahanga Catchment Consent Decision will be settled by this time.
