**Implementation and Management**

Mayor Terris said it was important that the group responsible for the implementation of the environmental strategy was politically accountable to the Wellington Regional Council.

Members discussed the benefits of establishing a 'Friends of the River' group similar to the group working for the Waikanae and Otaki rivers. Councillor Harris suggested that schools and Probis groups should also be involved.

Other groups such as the Forest and Bird and other volunteer groups in the community should also be included.

Mayor Terris noted important links with Hutt City for a heritage trail.

**Wellington Regional Council Presentations on Environmental Strategy**

It was agreed by the meeting that officers should co-ordinate with the Upper Hutt and Hutt City Councils a programme to present the environmental strategy to various community groups surrounding the river. It was also agreed a presentation be given to both authorities.

**River Ranger**

Councillor Macaskill sought the views of the meeting on the proposed River Ranger. There was general support.

Mayor Terris said it would be useful to investigate honorary rangers for the river. The Hutt City Council said that such a scheme was working well at Pencarrow.

Mr Puketapu said that his Runanga was currently involved in the establishment of a fishing officer and said the exercise had some valuable applications for the wider environmental strategy.

## **Priorities**

Councillor Cousins queried the attention given to the western vs. the eastern bank. A proposal for a Bridle Trail from the Titahi Bay Pony Club was also noted.

Councillor Baird said that given budgetary constraints it was important at an early stage, to complete works such as attractive signage and interesting plantings in prominent places. These would have a very positive impact on recreational users.

Mayor Terris apologised for his early departure at 5.30pm as he had to attend an important civic function.
