**•Comments:**

In response to your current public consultation concerning proposed changes to the region's bus fares system, this facsimile contains the signatures of 328 Wellington residents who are opposed to the fare increases resultant from your proposal. The signatures were gathered by placing the petition forms in just two Island Bay fish and chip shops. They were gathered over a three week period by passive means - that is to say participants were not canvassed, encouraged or pressured to take part. That so many signatures were collected with such little coverage bears testimony to the depth of community Wing opposing this Issue.

The proposed changes result in savage increases, particularly in children's fares, almost entirely as a result of the ludicrous proposal to round fares up to the next 50c or whole dollar.

Today's children will be tomorrow's adult bus users. We should be encouraging them (and their parents) to use public transport rather than discouraging them as the proposed increases will surely do.

We have a great opportunity to increasing public transport patronage by developing 'the usage habit' at an early age, and reduced fares assist in this.

It is also socially irresponsible to direct the brunt of the savage increases at those least able to afford them - the young, the elderly and those on fixed incomes.

Please leave the fares as they stand at present.
