**PT 175 Public Participation**

**Mr Brent Efford, PT User Representative, Regional Land Transport Committee**

Mr Efford criticised the lack of a regionwide strategy for public transport. The corridor-specific process falls well short of a coherent Passenger Transport Strategy.

A copy of Mr Efford's written representations were circulated.

Councillor Turver, in thanking Mr Efford for his appearance before the committee, noted that a regionwide strategy was included in the RLT Strategy document.

**Mr J Ward, East by West Company**

Mr Ward commented on various aspects of the East by West proposal for a trial commuter ferry service from Petone to Wellington with reference to Dr Watson's Report 04.219 for consideration at today's meeting. This included comments on how the ferry proposals rated in the Hutt Corridor Plan, whether it should be an expedited tender or contract extension and whether the increased services should be a trial service.

**Western Corridor Plan Review**

Dr Watson said he was in discussions with Transit New Zealand preparing draft Terms of Reference to progress the Western Corridor Plan within the context of the recently amended Transport Management Act. The Terms of Reference will require the approval of Transfund New Zealand. It has been agreed that Greater Wellington Regional Council will be the lead agency. Dr Watson said Mr Harris, Chief Executive, will report progress at the next Council meeting on 31 May 2004.

Dr Watson said there were two additional items as follows:

**Letter dated 5 May 2004 from Hon Pete Hodgson Minister of Transport.**

The Hon Pete Hodgson, Minister of Transport has invited Councillor Shields to begin participation in dialogue with central Government on transport issues in the Wellington region. The Minister has invited Councillor Shields, Chairperson of the Regional Council to meet on 10 May 2004 to discuss various rail, road and passenger transport issues pertaining to the Wellington region.

Dr Watson said that Mr Harris, Chief Executive, will circulate a copy of the letter in the Bulletin, confirming the workshop on 20 May 2004 will brief Councillors on progress following the meeting with the Minister of Transport on 10 May. The Council meeting on 31 May will include an item on transport issues.

**Patronage Funding**

Dr Watson said following an audit by Transfund New Zealand Council had now some patronage growth credits which have to be spent in the 2004 year. These credits will be netted off against a lower than budgeted passenger growth income and will be used to pay for other budgeted items such as bus timetables which are costing more than was anticipated in the current financial year. Dr Watson said there will be a meeting with Transfund New Zealand to determine how the remaining credits can be applied. Dr Watson said that he hoped some could be applied to the Carterton commuter car park so that it can be completed a year earlier than expected. The credits will also result in an increase in the end-of-year transport reserve.

## Other Matters

### PT 181 Questions

#### **Parking in the Karori Tunnel**

Responding to a question from Councillor Barr Councillor Turver said that the question of cars parked at the Karori Tunnel were a matter for the Wellington City Council and it will be discussed when the Quality Partnership Agreement Group next meets.

### PT 182 General

#### **Public Transport Strategy**

Councillor Barr said he agreed with the comments of Mr Efford earlier in the meeting about the need to consider a Public Transport Strategy regionwide. Councillor McDavitt said such a policy was included in the Regional Land Transport Strategy and will be reviewed later in the year.

### PT 183 **Presentation by Alistair Page, Managing Director of Action Information Management Ltd on Real Time Passenger Transport Information**

Mr Page gave a presentation focussing on the Company's experience with implementing real time passenger transport information in the United Kingdom.

The system produced continuous improvement in service delivery, improvement in customer services, analysis of real time projects and showed up the critical success factors for tracking and management systems. The presentation showed the importance of database management and how service monitoring could be improved.

Following questions Councillor Turver thanked Mr Page for an excellent presentation.
