**Minutes of the Extraordinary Wellington Regional Council meeting held in the Council Chamber, Regional Council Centre, 142 Wakefield Street Wellington, on Tuesday, 15 March 2011 at 1.06 pm**

**Present**

Councillors Wilde (Chair), Aitken, Brash, Bruce, Donaldson, Glensor, Greig, Laidlaw, Lamason, McPhee, Ponter, Swain, and Wilson.

The Chair commented on the Japanese earthquake and tsunami of 11 March 2011, acknowledged the huge loss of life, and asked all present in the Chamber to observe one minutes silence.

**067 Apologies**

There were no apologies.

**068 Conflict of Interest declarations**

Councillor Swain declared a conflict of interest in Item 10: Ngāti Toa Rangatira Treaty of Waitangi negotiations, and left the Chamber during consideration of the report.

070 **Annual public transport fare review 2011**

1. *Receives the report.*

3. *Notes that the Council Ten Year Plan 2009-19 assumes a fare revenue increase of 3% per annum from 2010/11 onwards.*
4. *Notes that the draft Council Annual Plan for 2011/12 assumes a fare revenue increase of 3%.*
5. *Notes that farebox recovery levels are predicted to fall below the Council target level of 45-50% within the next two years.*
6. *Agrees that fares be increased from 1 September 2011 to generate a revenue increase of 3%, subject to satisfactory agreement of contractual terms with operators which see the financial benefits of the fare increase flowing to the Council.*
7. *Agrees that the preferred fare increase scenario set out in this report, i.e. approximately 5% increases for multi-trip tickets, be the basis of discussion with operators, but acknowledge that all options remain open at this time.*
8. *Notes that reports on progress with operator discussions will be reported back to the Economic Wellbeing Committee.*
9. *Notes that consultation on the proposed fare revenue increase will occur with the public as part of the preparation of the Council Annual Plan, and that the increase cannot be confirmed until the completion of the Annual Plan.*
10. *Notes that a farebox recovery policy based on a recovery rate of 50% - 55% is included on the agenda of the Economic Wellbeing Committee for its meeting of 17 March 2011.*

Councillors Bruce, Ponter, and Wilson asked that their votes against recommendations 6 and 7 be recorded.

  10. *Notes the summary document will also include information on the proposal to participate in the establishment of the Local Government Funding Agency, the proposed Dangerous Dams Policy and the proposed Resource Management Charging Policy (2011).*
