### Notice of person's wish to be party to proceedings

I, New Zealand Transport Agency Waka Kotahi (NZTA), wish to be a party to the following proceedings:

Appeals on Proposed Plan Change 1 to the Regional Policy Statement for the Wellington Region.

I am, a person who made a submission about the subject matter of the proceedings.

I am not a trade competitor for the purposes of [section 308C](#) or [308CA](#) of the Resource Management Act 1991.

I am interested in all (*or* part of) the proceedings.

The part of the proceedings I am interested in is:

The following proposals by Porirua City Council:

- delete Policy CC.2;
- delete Policy CC.2A;
- amend policy CC.9
- amend Policy UD.3;
- amend objective 16;
- amend Policy 29;
- amend objective 22;
- amend Policy 51;
- amend Policy 55;
- amend Policy 56;
- amend Policy 57; and
- amend Policy 58.

I am interested in the following particular issues:

The above provisions relate to the effects of the provision transport infrastructure and its interaction with land use development.

I oppose the deletion of policies CC.2 and CC.2A as these policies require development to provide travel choice assessments which would identify adverse effects and provide information for infrastructure providers such as NZTA and councils to plan investment. I oppose the amendments to Policy CC.9 as the amendments would reduce the effectiveness of this policy. I oppose the amendment of Policy UD.3 and Objective 22 as these provisions are

required to provide a framework for reverse sensitivity provisions in district plans and to ensure transport and land use development are integrated. I oppose the amendment to Objective 16 and Policy 29 as it is unclear what effect the proposed changes would have. I support the changes to policies 51, 55 as they will enable development while managing effects of natural hazards.

I oppose the changes to Policies 55, 56, 57 and 58 as these policies are required to integrate land use development and infrastructure provision.

I agree to participate in mediation or other alternative dispute resolution of the proceedings.

### **Note to person wishing to be a party**

You must lodge the original and 1 copy of this notice with the Environment Court within 15 working days after—

- the period for lodging a notice of appeal ends, if the proceedings are an appeal; or
- the decision to hold an inquiry, if the proceedings are an inquiry; or
- the proceedings are commenced, in any other case.

Your right to be a party to the proceedings in the court may be limited by the trade competition provisions in [section 274\(1\)](#) and [Part 11A](#) of the Resource Management Act 1991.

The notice must be signed by you or on your behalf.

You must serve a copy of this notice on the relevant local authority and the person who commenced the proceedings within the same 15 working day period and serve copies of this notice on all other parties within 5 working days after that period ends.

However, you may apply to the Environment Court under [section 281](#) of the Resource Management Act 1991 for a waiver of the above timing or service requirements (*see form 38*).
